With reference to the above cited subject, as per reference (1) a conditional Fire Safety Recommendation Certificate was issued for the "M/s. Chamundeshwari Educational Trust, B.M. road, Vivekananda nagara, Ramanagara – 562 159." to the Management from this office for the fire fighting systems to be installed within 90 days including training part.

As per reference (2) the Management installed all the fire fighting systems and request to the department to issue compliance certificate for the same.

As per reference (3) the District Fire Officer, Ramanagara Fire Station, Ramanagara was inspected the 03 polytechnic blocks/ buildings i.e. Polytechnic block – 1 comprising of Ground & 03 floors with a height of 14.85mtrs. Polytechnic block – 2 comprising of Ground & 03 floors with a height of 14.36mtrs and Polytechnic block – 3 comprising of Ground & 03 floors with a height of 13.36mtrs and submitted the report that the applicant has fulfilled all the fire fighting systems as per requirement and found the fire fighting systems are in good working condition during the time of inspection except training part and recommended to issue compliance certificate for the same.
