Polytechnic block - 2 comprising of Ground & 03 floors with a height of 14.36mtrs and Polytechnic block - 3 comprising of Ground & 03 floors with a height of 13.36mtrs and submitted the report that the applicant has fulfilled all the fire fighting systems as per requirement and found the fire fighting systems are in good working condition during the time of inspection except training part and recommended to issue compliance certificate for the same.


