

Minutes shall be kept of the names of the Trustees and the members of the Committee present and of the procaedings at each meeting in a book to be provided for this purpose, which shall be read and signed at the next ensuing meeting by the Chairman of such meeting, and shall be open to inspection by any Trustee during office hours.

18. Accounts:

The accounts of the Trust shall be made from 1st Jannuary to 31st December in each year. The members of the Trust shall cause true accounts to be kept in such manner as they think fit of all the receipts, credits, payments, assets and liabilities of the trust. Such books and all vouchers relating thereto and all the documents belonging to the Trust shall be kept relating

19. AUDIT:

The accounts of the Trust shell be audited by an auditor or auditors who shall be chartered Accountant or a firm of Chartered Accountants, who shall be appointed every year by the members of the Trust at the Annual General Meating. The Trustees shall, at such meeting, also fix the remuneration, if any, to be paid

20. Service of Notices:

- (a) Every Trustee shall from time to time in writing specify to the Board of Trustens or such persons as may be appointed by the Trustees in that behalf, his address to which notices and other communications from the Trust may be sent, which shall be entered in the Books of the Trust.
- (b) Service of a Notice by post shall be complete by properly addressing and pro-paying the postage and posting a letter containing the notice and unless the contrary is proved, shall be deemed to have been effected at the time at which the latter would be delivered in the ordinary course of post.
